Treasurer's Report 2020

## Summary

The Society enjoyed another strong year financially in 2020, with funds and reserves of over £46,000 at the year end. This figure includes our Emergency Fund of £10,000 and a grant of £5,000 from LB Barnet for the final phase of the fence along Gordon Road. This work is planned for early 2021. We have not increased rents or service charges for 2021. The restrictions on activities caused by COVID19 meant we were unable to hold any social events or outings, but the plant sale did take place in a reduced format for members only and it raised over £1,300. The trading hut generated the same level of income as 2019, confirming its continued value to members.

## Accounts

The accounts which follow are set out over three pages which hopefully make them easier to read. The figures for 2020 are shown with those for 2019 for comparison.

The first page shows receipts and payments for both years. Receipts include the LB Barnet grant of £5,000. Payments were significantly lower than 2019 mostly due to the expenditure in that year on the Dollis Road section of the fence. Both water and electricity charges are now paid by direct debit but these can be expected to increase during 2021, dependent on actual consumption.

The third page shows the funds and reserves held by the Society and concludes with the signatures of the independent examiner and the Chair. We are grateful to Jane Healy for continuing to be our independent examiner.
